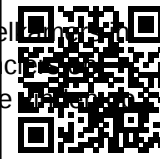

Prepares reports at the end of a shift, day or period, including staff control, hygiene, and health and safety;

Checks stock levels, order supplies and controls (maintains) china, cutlery, glassware, linen, equipment or other non-food related products such as housekeeping supplies and chemicals;

Perform 'Manager on Duty' assignments and participate in Department Head meetings.

You are a team player, with a hands-on mentality whom isn't shy for a day's hard work, versed in more than only cleaning but also see to maintenance & repairs of the equipment / machinery, has an eye for details in regards to the upkeep of the front plus back of house area's and can handle pressure.
